

# CARES ACT REPORTING **FINAL REPORT**

**UPDATED: As of March 31, 2021**

## **HEERF Emergency Financial Aid Grants to Students**

The recently passed Coronavirus Aid, Relief, and Economic Security (CARES) Act includes a Higher Education Emergency Relief Fund (HEERF) that was set up to provide over \$14 billion in emergency funding to higher education. More than \$6 billion of this funding must go directly to students as emergency financial aid grants for expenses they have incurred relating to the disruption of campus operations due to the COVID-19.

### **Certification and Agreement Acknowledgement:**

Shorter University acknowledges that a signed Certification and Agreement was submitted to the Department of Education on April 9, 2020. This agreement indicated our commitment and assurance that Shorter University would use no less than 50% of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.

### **Funds Received per the HEERF Grant:**

Shorter University applied for and received a total of \$604,040 for the Higher Education Emergency Relief Funds for students grants. The funds were received on April 22, 2020.

### **Distributed Grants:**

As of March 31, 2021 \$604,040 of the HEERF student grants have been distributed to students.

### **Grants Awarded:**

824 students were eligible to receive an Emergency Financial Aid Grant received a grant.

### **Distribution Methodology:**

To Determine the distribution method for the HEERF Grants, priority was given to students that lived on campus, purchased a meal plan and were Pell eligible. Additionally, all traditional Title IV eligible students received a grant to assist with the cost of transitioning from on-ground classes to online.

We are pleased to announce that you will be receiving an emergency grant from the CARES Act Stimulus Package.

The emergency grants are designed to assist students with the disruption of services due to the closing of campus as a result of Covid-19. Shorter University used the matrix below to determine each traditional Title IV eligible student's grant.

Example 1: If you are Pell eligible, lived on campus and purchased a meal plan. You are receiving a grant for \$750.00 plus an additional grant of \$275.00 for expenses related to transitioning online for a total grant of \$1,025.00.

Example 2: If you lived on campus and purchased a meal plan. You are receiving a grant of \$450.00 plus an additional grant of \$275.00 for expenses related to transitioning online for a total of \$725.00.
